- 2. Declarations of Interest. Nil
- 3. Minutes of the meeting held 12th December 2016. Approved
- **4. Matters Arising.** Hedge cuttings on footpaths. Fens to The Tall Ships lighting. JL will raise at Parish Liaison meeting.

5. Clerks report and correspondence.

- a) The Clerk advised that he would be willing to serve until April 2017 so that the audit would be covered
- **b)** SLCC News Bulletin December 2016. Government will not be applying referendum principles to English parish precepts. Noted.
- c) Defibrillator. Needs to have a weekly maintenance. KP will chase up the details.

6. Reports on:

a) Roads and Paths. Outside of Clevecoat the drains have been altered to avoid dampness. It was noted that on occasions of heavy rain flooding had occurred here.

Clerk advised that he had had several meetings with the foreman Of the Raby Arms development site regarding the damaged turf in Voltigeur Drive. He promised to do the job himself as their landscape department had failed.

Worset Lane damage was discussed further, but HBC have claimed money shortage prevent a full repair.

Contentious yellow lines at the junction of Butts Lane and Front Street. Parking is causing a problem. Need to keep an eye on the situation.

b) Lights. All appear to be working. The tree in Clevecoat must be trimmed or cut down. PB will take it up tomorrow

c) Amenities

Repeated appreciation for the Christmas tree had been received.

7. Finances

8. Planning Applications.

a. **H/2016/0362 Middle Thorpe Farm withdrawn.** Bats inspection needed in spring.
